The Schedule for Online Spot Counseling for the seats remaining vacant after conclusion of Sliding Round and reporting of such candidates admitted in respective University Schools of Studies/ Colleges/Institutions:

## I) Who are eligible for Spot Round of Online Counselling:

### ADMITTED CANDIDATES

1. A candidate who was allotted a seat in the Online Counselling, paid the requisite Part Academic Fee of Rs. 40,000/- and reported at the allotted college/institute in the notified date & time.

### NOT ADMITTED CANDIDATES

2. A candidate who was allotted a seat in the Online Counselling, paid the requisite Part Academic Fee of Rs. 40,000/- but did not report at the allotted college/institute in the notified date & time.
3. A candidate who was allotted a seat in the Online Counselling, paid the requisite Part Academic Fee of Rs. 40,000/- and subsequently withdrawn as per procedure.
4. A candidate who was allotted a seat in the Online Counselling, but did not pay the requisite Part Academic Fee of Rs. 40,000/-.
5. A candidate who has not been allotted any seat in any rounds of the Online Counselling.
6. All the registered candidates who have paid the Application Fee of Rs. 1200/- and the Counseling Participation Fee of Rs. 1000/- but did not fill choices.
7. All 'Not Admitted' candidates.
8. Allotted candidates who had chosen Freeze / Float options

## II) Spot Round Procedure:

- i) Registration for SPOT Round will be for all CET 2021 qualified candidates irrespective of his/her registration earlier.
- ii) The "Spot Counselling" shall be done for vacancies remaining after reporting of allocated candidates to Schools of Studies / Colleges / institutions allotted and arising during the process of "Spot Counselling". Since, all conversions of categories / region-wise divisions are completed in the last round of online counselling (Section 10.8 of admission brochure 2021-22), the spot counselling shall consider all seats to be filled as unreserved.

- iv) ALL PREVIOUS CHOICES SHALL BE TREATED AS NULL AND VOID. CANDIDATES DESIROUS OF PARTICIPATING IN THE SPOT COUNSELLING SHALL HAVE TO FILL CHOICES/PREFERENCES AFRESH.
- v) The candidates who have reported at their respective School of Studies/Colleges/Institution after seat allocation upto Sliding Round, if participating in the Spot Round are assured that if any of the new preferences filled in the Spot Counseling is not allocated to them, their existing allocation of seat shall be retained and shall not change.
- vi) The candidates who have reported at their respective School of Studies/Colleges/Institution after seat allocation upto Sliding Round, if participating in the Spot Round and if any of the new preferences filled is allocated to them in the Spot Round of Counseling then, the candidate shall be abide to take the new allocated seat and they will not have any claim on the previous seat.

### \*\* Adjustment of Part Academic Fee in SPOT ROUND of Online Counselling:

Candidates whose name appeared in Common Merit List Rank 2021 of GGSIP University, who have been allotted seat in the previous rounds of Online Counselling and had paid the Part Academic Fee of Rs. 40,000/- and wish to participate in the Spot Round of Counseling, their part Academic Fee of Rs. 40,000/- (Rupees Forty Thousand only) paid in the earlier rounds of Online Counselling will be adjusted during the Spot Round of Online Counselling. Such candidates, if allotted a seat in the SPOT ROUND of Online Counselling need not pay the Part Academic Fee of Rs. 40,000/- again.

The following candidates need not to pay again the Part Academic Fee of Rs. 40,000/- (Rupees Forty Thousand Only) during admission in SPOT ROUND of Online Counselling (i.e. if a seat is allotted in the Spot Round of Counselling):

- A candidate, who was allotted a seat in any round of Online Counselling and paid the Part Academic Fee and Reported.
- A candidate, who was allotted seat in online round of Online Counselling, paid the Part Academic Fee but did not report in the allotted institute.
- Any candidate, who was admitted in any round of Online Counselling, paid the Part Academic Fee and subsequently withdrawn as per procedure.

### VI) Reporting of candidates to the allotted institute/college:

- After declaration of result of SPOT Round of Online Counselling, the candidates allotted seat, have to report to the allocated University School/Institutions for verification of documents and payment of balance Part Academic Fee as per the Offer letter of result of Spot Round of Online Counselling.
- After allotment of seat in the Spot Round of Counselling, the candidate, if allotted a seat/retained the seat from earlier allotment/upgraded to higher choices/preferences, and if he/she has made the payment of Part Academic Fee of Rs. 40,000/- (if not paid earlier), can generate Provisional Admission Slip.

- iii) Proof of payment of Part Academic Fee receipt of Rs. 40,000/- is available in the candidate's profile.
- iv) The candidates are required to report and join the respective School/College with the Provisional Allotment Letter and the necessary record for verification of documents at the School/institution/college and pay the balance Academic Fee (if any), as per the schedule notified on the website, failing which the admission shall be automatically cancelled.
- v) All admissions shall be provisional till regularized by the University.
- vi) **Result Awaited candidates** may please see the provisions contained in the **clause 3.5 of Chapter 3 of Admission Brochure 2021-22** and University Notification No. GGSIPU/Admissions/2021-2022/1406 dated 18.11.2021.
- vii) Candidates who report to the allotted institutions and are reflected in the list submitted by the institutions as reported/admitted, shall be called "admitted students".

### Important Note:-

- i) Admitted Candidates who are allotted an upgraded seat in the Spot Round of Counselling need to pay an additional amount of Rs. 5000/- at the newly allotted University School/Affiliated College.
- ii) **The upgraded candidates have to pay the balance academic fee (if any), at the newly allotted college/institute/University School. The balance fee paid by such candidates in their previously allotted/reported college/institute shall be refunded to them by the respective college/institute.**
- iii) The candidates are required to take their original documents and a set of photocopy of the documents for submission at the concerned School/Institute/College along with Medical Certificate (**Appendix 6**) in original, Character Certificate (in original), Reserved Category certificate/Minority Certificate, and other related appendices such as for Defence Category - **Appendix 1** available in the Admission Brochure 2021-22 duly filled and signed. Result awaited candidates will have to submit duly filled and signed **Appendix 5** of Admission Brochure 2021-22.
- iv) It is the responsibility of the candidates to ascertain whether he/she possesses the requisite eligibility and qualifications for admission.
- v) For ascertaining the eligibility conditions, combination of marksheets, shall be allowed, only and only if the marksheets are from the same Board. If any particular candidate changes the Board e.g. CBSE to NIOS, an appropriate proof of accepting the marks of the earlier Board shall be required by the new Board. Thus, such candidate shall supply the one complete marksheet making him eligible. The decision for ascertaining the region will be based on the documents produced by the candidate.
- vi) The candidates who have passed the qualifying examination through Distance/Open Education system of any recognized University/ Institute and had his/her Study Centres in Delhi, such candidates will have to provide proof of his/her study centre proof for determining his/her Region. The candidates who fail to provide the proof of his/her study centre issued by the respective Board / University of being located in Delhi shall not be considered for Delhi region Seats, and shall be considered for admission in the Outside Delhi Region Category. The candidate must bring in writing the certificate issued by the concerned University imparting Distance/ Open Education stating clearly that the study centre of the candidate is/was in Delhi or Outside Delhi.

vii) **In Affiliated Colleges/Institutes of GGSIPU:** The balance amount of fees may be submitted through both Online (Net Banking/ Credit Card/ Debit Card) and Offline (through Demand Draft) as per the instructions issued by the respective Affiliated College/Institute.

viii) The concerned Dean/Director/Principal, USS & Affiliated Colleges/Institutes will ensure that the Result Awaited candidates will have to submit duly filled and signed Appendix 5 of Admission Brochure 2021-22. The Dean/Principal/Director shall be responsible to ensure mechanism to monitor the cases of such candidates admitted provisionally to ensure that the candidates are informed prior to the due date of submission of their result as mentioned in the Admission Brochure 2021-22, failing which, shall result in cancellation of their admission in the respective programme and whatsoever, the reason may be, his/her admission will be treated as null and void and the entire fee will be forfeited and under no circumstances, he/she will be allowed to appear in the End Term Exam.

VII) The Dean/Director/Principal will be responsible to ensure that the eligibility of all the students are checked by them to ensure correctness of admission specially in case of provisionally admitted students.

## VIII) Terms And Conditions For Candidates Participating In Spot Counselling:

### A. Terms And Conditions For New Entrants:

That if a seat according to his/her choices / preferences of Institution / programme is allocated to him/her then he/she shall deposit Part Academic Fee of Rs. 40,000/- for the allotted Institute / programme.

### B. Those Who Were In Online Counselling System And Have Been Allocated A Seat And Have Also Reported As Admitted:

(i) That if a seat in Spot Counselling according to his/her choices / preferences of Institution / programme is allocated to him/her then he/she shall deposit additional amount of Rs. 5,000/- as Upgradation fee charge.

(ii) That fee paid at the Institution level where he/she was earlier allocated shall be refunded to him/her by the Institution as per the University procedure for refunds in this case.

(iii) That if new seat is allocated to his/her in Spot round of Counselling then he/she abide to take the new allocated seat and do not have any claim on the previous seat.

### C. For Those Who Are Already Registered And Have Not Been Allocated A Seat Or Filled Any Choices:

That if a seat according to his/her choices / preferences of Institution / programme is allocated to him/her then he/she shall deposit Part Academic Fee of Rs. 40,000/- for Institute / programme.

### D. For those who were allocated a seat did not pay Rs. 40,000/- part academic fee:

That if a seat according to his/her choices / preferences of Institution / programme is allocated to him/her then he/she shall deposit Part Academic Fee of Rs. 40,000/- for Institute / programme.

### E. Already Registered / Seat Allocated Paid The Fee Then Withdraw Or Not Reported:

That if a seat according to his/her choices / preferences of Institution / programme is allocated to him/her then he/she shall deposit Part Academic Fee of Rs. 40,000/- for Institute / programme.
